## Camp Staff and Counselor Qualifications 2025

All Staff and Counselors Must:

- \* Have confidence in your salvation through the Lord Jesus Christ and be able to articulately convey this.
- \* Be actively involved in a Bible-believing Church.
- \* Be a female at least 15 years of age to work with the 7-12 girls' groups, or at least 13 years old and female to be a CIT.
- \* Be a female at least 18 years of age to work with the teen girls' group.
- \* Be a male at least 15 years of age to work with the 7-12 boys' groups, or at least 13 years old and male to be a CIT.
- \* Be a male at least 18 years of age to work with the teen boys' group.
- \* Read, fill out and sign necessary forms for participation in all Camp activities.
- \* Have required references filled out, signed and returned before the start of Camp.
- \* Be able to counsel a child about their need of the Lord Jesus Christ as their Savior and Lord.
- \* Be able to periodically lead cabin devotions with the children in your cabin.
- \* Be able to work well with the rest of the staff.
- \* Be a godly influence in the lives of the children, without being on their level (ex: not acting immature, as to be their "pal", but instead to be their *leader* with love.)
- \* Be able to spend the entire week(s) with your assigned children for the entire day and night. Not necessarily alone with just your group, but responsible for knowing where they are and what they are doing at all times, being sure of their supervision. (You will be given assigned breaks when others are watching your kids, but these must be assigned or approved by Mr. Aaron).

5. I will make every effort to share and explain the Gospel with the children as God gives me opportunity.
6. I will not sing or play any music that does not give Glory to God. I understand that **ALL** music must be approved by Aaron prior to camp.
7. I will not use inappropriate language at any time. I will not participate in any impure or unholy conversations.
8. I will conduct myself in a Godly Biblical manner at all times toward the opposite sex. This includes no hand-holding except during prayer circles. I understand that “pairing-up” and boy-girl relationships are not to be obvious to campers. I understand that inappropriate behavior in this area can result in my being asked to leave.
9. I understand that violent behavior toward anyone is totally unacceptable and I will be asked to leave immediately.

## Camp Staff and Counselor Dress Code 2025

Children are very impressionable. They learn from what we tell them, but A LOT from what we show them. This is why we do everything the way we do it. This is why we stress showing God’s love and using God’s Word.

The way we dress is **no** exception. Although we have camp divided into boys’ weeks and girls’ weeks, we still want to set the Godly example that they might not get anywhere else. We want them to realize that there are Godly standards that *they* should live by and dress by.

The parents may expect a certain standard from our staff and we want to live up to it. We don’t want them leaving thinking we have immodest Counselors and Staff.

We also have unannounced guests at times. We want them to have a good impression of the camp, since Godliness is what *Camp Good News®* is all about.

Although the world has a standard of their own, they have an even higher standard that they hold Christians to. We want to exceed even that.

Therefore, we ask that you abide by the following dress code:

### **Gentlemen:**

- T-shirts are best, no torn shirts
- Neat hair cut
- No body-piercing jewelry
- Long shorts or long pants, no torn jeans
- Always wear a shirt to meals and when ladies (or girls) are present  
(exception: pool; slip-n-slide; and games that Mr. Aaron exempts)

### **Ladies:**

- T-shirts are best. No tank tops, torn shirts, crop tops, tight shirts, or anything low cut  
(exceptions: pool; slip-n-slide)
- Long pants, skirts, or shorts. No torn jeans  
Shorts should be long enough to where when you stand with your hands by your side your shorts should extend past the end of your fingers. (Basketball shorts are always appropriate, and while not “flattering”, these are typically a safe bet!)
- No two-piece bathing suits
- No body-piercing jewelry except earrings and simple nose rings
- Any tattoos must be covered up

Remember when you sign this application you agree to abide by this dress code because of your devotion to the Lord’s work. If you fail to do so, you will be asked to change into something more appropriate. Please don’t get offended, we are not trying to be mean, just follow the dress code. If you cannot or will not, you will be asked to leave! If you have any questions, please ask Mr. Aaron or Ms. Maitland before you pack.
